This is in reference to the UGC letter dated 10th June 2024 regarding the "Guidelines on Public Self-Disclosure by Higher Education Institutions - 2024," which was circulated to all state universities with a request for strict compliance.

As per the guidelines, all Higher Education Institutions (HEIs) are required to maintain a functional website to ensure transparent dissemination of relevant information to stakeholders. The disclosed information should be readily accessible to everyone without any need for registration or login. Additionally, a search facility should be available on the website to facilitate easy navigation.

Additional Instruction for Web Integration:

To enhance accessibility and streamline navigation, it is requested that a single dedicated tab titled "Public Self Disclosure (PSD)" be created on the university website. This tab should serve as a centralized repository for all parameters. Each parameter should be hyperlinked within the PSD tab to its corresponding document or webpage, ensuring clarity and ease of access for stakeholders.

Furthermore, it is advised that all currently available information be uploaded and updated periodically, in accordance with evolving compliance requirements.

It is anticipated that the above measures will facilitate the seamless integration of self-disclosure content while ensuring compliance with UGC's transparency norms.
